Performance with care for the environment

With its sophisticated and technologically advanced range of engines, Citroën is well placed to reconcile performance with low taxation levels and reduced environmental impact.

Today more than ever, this means that when choosing a Citroën vehicle you are guaranteed access to superb value for money motoring.

For example, the Citroën C3 Origin MAX, when specified with the PureTech 110 S&S 6-speed manual engine produces only 123g/km of CO₂ and therefore qualifies for the G band of Vehicle Excise Duty.

Company Car Benefit-In-Kind Taxation Charges

The Company Car Benefit-In-Kind Taxation charge is based upon the type of fuel used, and the level of CO₂ emissions, measured in grams per kilometre (g/km). The table below shows the percentage of the car's list price to be taxed (P11d value[†]).

For example a New Citroën C5 Aircross MAX BlueHdi 130 S&S EAT8 has a CO₂ emissions figure of 145g/km and a P11d figure of £29,805.00.

The BIK value would therefore be 34% x £29,805.00 = £10,133.70.

Graduated Vehicle Excise Duty (Road Fund Licence)

The Graduated V.E.D. bands classify all new cars into one of thirteen Vehicle Excise Duty bands, depending on their type of fuel and carbon dioxide (CO₂) emissions level, measured in grams per kilometre (g/km). There are two V.E.D. rates, a rate for the first year and a rate for subsequent years.
